<p>Violation #16. Food-contact surfaces; cleaned & sanitized At the time of inspection observed residue built up on blade can opener. Clean and disinfect can opener. Staff cleaned and disinfected can opener . COS</p> <p>CODE REFERENCE: 64E-11.003(2). Food shall only contact surfaces that are clean and sanitized.</p>
<p>Violation #21. Hot holding temperatures At the time of inspection at the warmer observed cheese bread at 130 F (out of temperature) Provide at least 135 F for hot holding . Staff adjusted temperature of warmer . Retested temperature 150 F . CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.</p>
<p>Violation #22. Cold holding temperatures At the time of inspection at the line observed salad at 44 F (out of temperature) . Cold holding food items shall be at least 41 F. Staff placed salad in the freezer . Retested temperature at 41 F . COS</p> <p>CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.</p>
<p>Violation #38. Insects, rodents, & animals not present At the time of inspection observed air curtain out of order . Repair or replace air curtain . Staff provided work order # 4315022</p> <p>CODE REFERENCE: 64E-11.003(5)(f). Effective measures shall be taken to control the presence of pests in the food establishment. Unless otherwise approved, live animals shall not be allowed.</p>
<p>Violation #54. Garbage & refuse disposal At the time of inspection observed dumpster drain plug missing . Provided drain plug .</p> <p>At the time of inspection observed dumpster lids open . Close lids to prevent vermin of pest . Staff closed lids . COS</p> <p>CODE REFERENCE: 64E-11.003(5). Garbage shall be disposed of to prevent vector harborage. Trash cans will be durable, cleanable, leak proof, insect and rodent resistant, and non-absorbent. Outside storage area shall be of a smooth, non-absorbent material and sloped to a drain.</p>
